He was appointed the 19th Group Managing Director (GMD) of the Nigerian National Petroleum Corporation (NNPC) in July 2019 and transitioned to become the Group CEO following the incorporation of NNPC Ltd.

He joined NNPC in 1991 and has served in various roles within the Corporation. In 2015, Mr. Kyari was appointed Group General Manager, Crude Oil Marketing Division, where he made positive impact for NNPC and Nigeria with outstanding achievements that include optimally securing Federation entitlements from production/fiscal arrangements and resolution of various disputes on PSCs.

He also successfully managed the Direct Sales and Direct Purchase (DSDP) arrangement of petroleum products to ensure energy security. From championing EITI and Open Government Partnership principles, promoting the passage of the Petroleum Industry Act and driving the transition to NNPC Ltd, declaring the Corporation's first profit in her 44 year history and resolving the decade-long PSC disputes to unlocking the deepwater, introducing cost discipline, rehabilitating ailing refineries and other critical downstream infrastructure, deepening domestic gas utilization, public disclosure of NNPC accounts, the first in the Corporation's history, Kyari has championed Transparency and Accountability and Performance Excellence.

Other achievements include rallying shareholders to take the FID for NLNG Train 7, transforming the Corporation to a world-class organisation and leading concerted efforts in driving environmental policies for cleaner energy. Aside being a Fellow of the Nigerian Association of Petroleum Explorationists (FNAPE), Kyari is also Nigeria's National Representative to the Organisation of Petroleum Exporting (OPEC) Economic Commission Board (ECB).

Isa Ali Ibrahim, PhD (Pantami) is the Minister of Communications and Digital Economy of the Federal Republic of Nigeria. He holds a B.Tech and MSc in Computer Science, an MBA in Technology Management and a Doctorate in Computer Information Systems. He is a Professor of Cybersecurity.

Prior to his appointment as a Minister, he was the Director General (DG)/Chief Executive Officer (CEO) of the National Information Technology Development Agency (NITDA), which has a mandate of Research and Development in Information Technology. He is currently the Chief Digital Officer of the Federation, based on the National Policy for Virtual Engagements in Federal Public Institutions. He also serves as Chairman and member of several Presidential and Inter-Ministerial Committees and has received over 150 awards, including the Award of Best Minister on multiple occasions.

Professor Ibrahim was appointed as the Chairman of the World Summit on the Information Society (WSIS) for the year 2022. The WSIS Forum, is co-organized by the International Telecommunication Union (ITU), UNESCO, UNDP and UNCTAD with the engagement of 28 other United Nations Agencies. He also chaired the Forum of ICT Ministers at the WSIS event in Geneva in May 2022. He is a speaker that is well sought after across the globe.

Professor Ibrahim also holds certificates in Digital Transformation from Harvard, Digital Strategy from both Massachusetts Institute of Technology (MIT) and Institute of Management Development Lausanne, Switzerland, Strategic Leadership from Oxford University, and a University of Cambridge Certification in Management. Professor Ibrahim lectured at the University for almost two decades, teaching ICT courses. He is still engaged with the academia as a professor.

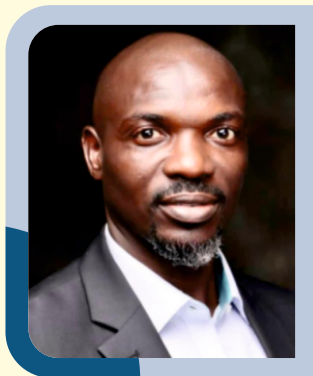
