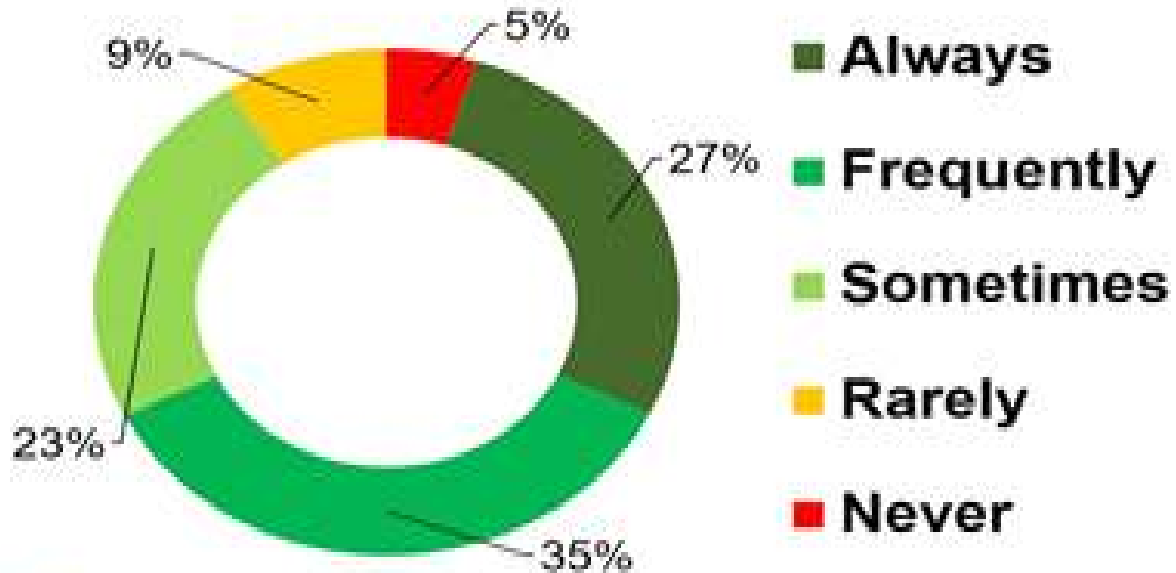

ISACA's newly released report reveals a critical insight: only 27% of organizations globally consistently implement Privacy by Design principles.

Despite growing regulatory pressures and digital transformation trends, the report shows:

- 35% of organizations sometimes embed privacy at the design stage.
- 23% do so frequently, while 9% rarely and 5% never apply it.

This gap underscores an urgent call for organizations to move beyond basic compliance and intentionally embed privacy into the DNA of their products, services, and systems.

At the press conference marking the opening of National Privacy Week, which aligns with the Global Privacy Day 2025, the National Commissioner/CEO of the NDPC, Dr Vincent Olatunji, delivered a welcome address and ecosystem briefing. The event also featured the unveiling of the NDPC's Annual Report and the maiden edition of its Journal.

In his address, Dr Olatunji highlighted several key achievements of the Commission since the previous Data Privacy Day. He noted that the NDPC, guided by its strategic roadmap, has made significant progress in advancing data protection and privacy in Nigeria. He also emphasised that the Commission's activities have gained global recognition, establishing the NDPC as a leader in Africa's data protection ecosystem. Additionally, he underscored the importance of cooperation, collaboration, human capacity development, and public awareness in fostering a strong privacy culture.

Dr Olatunji reiterated the Commission's commitment to job creation, particularly for

Nigerian youth, aligning with President Bola Ahmed Tinubu's Renewed Hope Agenda. He highlighted the recent launch of the National Certification Program for Data Protection Officers, aimed at certifying Data Protection Officers domestically. This initiative, he explained, has the potential to generate over 500,000 jobs within Nigeria's data protection and privacy ecosystem. He further stressed the importance of raising awareness about privacy, urging all stakeholders to work together to safeguard personal data and protect privacy rights.

The event also featured the official launch of the NDPC Annual Report and the Journal on Data Protection and Privacy. The Annual Report provides a detailed account of the Commission's activities and accomplishments over the past year, while the Journal serves as a platform for researchers, academics, and industry experts to publish and share innovative studies, findings, and advancements in data protection and privacy.

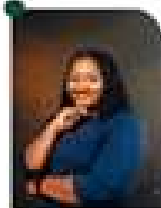

TO OUTSMART
A CYBERSECURITY ADVOCATE
PHISHERS DON'T REST
— AND NEITHER SHOULD WE.**



Shortly after featuring on **KAFTAN TV Abuja** to discuss the importance of cybersecurity awareness, I received a suspicious SMS claiming I had been credited **N99,400** for "child support" from "Ahmed Tinubu."



The message urged me to call a "Mr. Hamza" to claim the payment — a textbook case of **social engineering**.

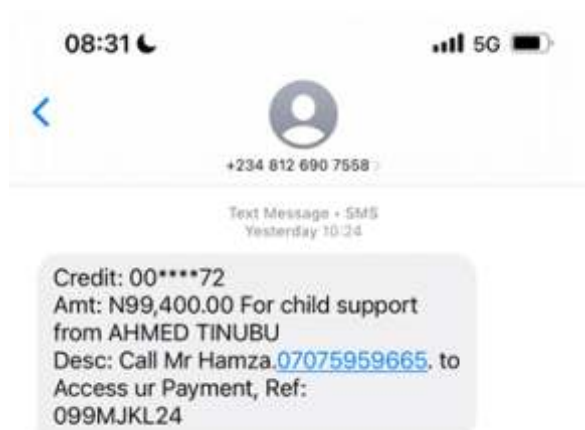
What We Learned from This Scam Attempt:

- **Random Deposits?**
If you didn't expect money, it's bait. Ignore it.
- **Urgent Call-to-Action?**
Scammers want to lure you into sharing personal information fast.
- **Masked Account Numbers?**
Vague banking details are classic signs of deception.
- **Famous Name Drops?**
Using well-known names is a trick to gain false credibility.

Moral of the Story:

- **Verify independently** before acting on any financial communication.
- **Never share** personal or banking information with unknown sources.
- **Report scams** to help others stay protected.
